 in the Parish of Shirley in the County of Derby or elsewhere in the said County (save  
 and except out of this demise the House and Lane now in Mortgage to Thomas Hensworth  
 of Ashborne and which I have promised to grant and convey to my Son John Jackson  
 and his Heirs and Assigns for ever paying and discharging the said Mortgage due  
 to Thomas Hensworth of Ashborne aforesaid) And also All my Goods (both Chattles  
 2 rights credits and Personal Estate whatsoever and wheresoever unto my Son  
 Joseph Jackson and William Jackson of Stanton in the County of Staffordesman  
 their Heirs Executors Administrators and Assigns Upon Trust nevertheless and  
 to the intent and purpose that my said Son Joseph Jackson and the said  
 William Jackson or the survivor of them or the Heirs Executors or Administrators  
 of such survivor do and shall with all convenient speed after my decease well  
 and dispose of all and every of my said Messuages Land Tenements  
 Hereditaments and real Estate (except as aforesaid) unto such person or persons  
 and in such manner as my said Trustees or the survivor of them or the Heirs or  
 Assigns of such survivor shall think fit and shall and do likewise with all  
 convenient speed get in sell and dispose of my said Personal Estate and by  
 the Monies arising from my real and Personal Estate to pay off and  
 discharge the Mortgage money (except as aforesaid) my just debts Funeral  
 Charges and the expenses improving this my will and from and after  
 4 Payment thereof I give and bequeath the residue and remainder of the  
 Money arising by the means aforesaid in manner following that is to say

 equal seventh part or share thereof To my Son George Jackson his Executors  
 Administrators and Assigns one equal seventh part or share thereof

To my Daughter Elizabeth Jackson her Executors Administrators and Assigns one Equal seventh part or Share thereof To my Son Humphry Jackson his Executors Administrators and Assigns one equal seventh parts or Shares thereof To my son Thomas Jackson his Executors Administrators and Assigns one equal seventh part or Share thereof To my son the said Joseph Jackson his Executors Administrators and Assigns one equal seventh part or Share thereof To my grandchildren Ann Jackson and Richard Jackson Daughter and son of my late son Richard Jackson deceased their Executors Administrators and Assigns the remaining one equal seventh part or Share thereof And it is my Mind and I do hereby declare it so to be that not any purchaser or Purchasers of my said real Estates or any part thereof shall be concerned to see the application of any purchase Monies by him her or them respectively paid or be in anywise accountable for the misapplication or non application of any purchase Monies by him her or them respectively paid but that the receipt or receipts of my said Trustees or the Survivors of them or the Heirs Executors or Administrators of such Survivors shall from time to time be good and sufficient discharge or discharges for the same And it is my Will and Mind and I do hereby declare it so to be that my said Trustees or the survivors of them or the Heirs or Assigns of such survivor shall not be charged or accountable for any more of the Monies and Effects than they shall respectively and actually receive nor for any losses that <sup>shall</sup> happen of the said Monies or Effects unless the same shall happen by the wilful neglect or default of them or either of them And lastly I do hereby nominate constitute and appoint my said son Joseph Jackson and the said Williams Jackson of Stanton joint Executors of this my Last Will and Testament hereby revoking and making void All former Wills by me made and I do hereby declare this only to be my Last Will and Testament In Witness whereof I have hereunto set my hand and Seal that is to say my hand to the first Sheet and my hand and Seal to this the last Sheet the 24 Day of March in the year of Our Lord one Thou and seven Hundred and Eighty five. +
